TRANSPARANCY LEGISLATION

Legal information to be provided in accordance with Article 14 of the Transparency Legislation (Law of 02/05/2007-BS 12/06/2007)

Notification from Sioen Industries NV, Sihold NV, Sicorp NV, Stichting Administratiekantoor MIDAPA and Mrs. Jacqueline Sioen-Zoete d.d. 07/03/2014, announcing that due to a passive threshold crossing and the transfer (destruction) of voting securities or voting rights, the participation of Sioen Industries NV is 0% and the participation of Sihold NV 65.10% of a total of 19 825 903 voting rights on 24/01/2014.

The total participation of all notified parties amounts to 65.10% at the end of the day (12 906 212 voting securities).

Sioen Industries is controlled by Sihold NV. Sihold NV is controlled by Sicorp NV. Sicorp NV is controlled by Stichting Administratiekantoor MIDAPA, which is controlled in its turn by Mrs. Jacqueline Sioen-Zoete.
